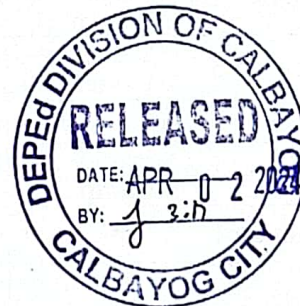

Greetings of Peace and Solidarity!

The 43rd Infantry "We Search" Battalion, 8th Infantry "Stormtrooper" Division, Philippine Army continues its mission in maintaining peace and order in our area of operations. One of which is the **Information Awareness Drive on RA 10168 (Ungayan sa Paaralan), Executive Order (EO) 70, International Humanitarian Law (IHL), Anti-Terror Act (ATA) 2020, and other matters** in all Secondary Schools and State Colleges and Universities within our unit AO in order to prevent/end the illegal recruitment of students by the Communist NPA Terrorists (CTGs) to join their ranks as child warrior or regular NPA.

IHL prohibits the recruitment and use of children in hostilities. The prohibition in both international and non-international armed conflicts. The ban on recruitment of children below the age of 15 enshrined in Article 77 of the Additional Protocol 1, and in Article 4 of Additional Protocol 2 are also considered to prohibit accepting voluntary enlistment (P1, Art. 77 (2); P2, Art. 4(3)(c).
