| May 16, 2024 | Calbayog 4, 5, 6 | Trinidad Covered Court |

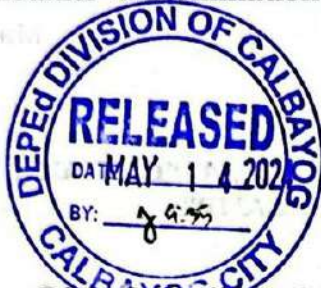
2. The participants of the said orientation shall likewise include administrative officers of the schools/districts.

3. The deadline of **online** accomplishing of the **List of Learning Camp Volunteers** as well as the **number of learners per camp per grade level** shall be on or before **May 17, 2024**. The sheets shall only be accomplished by school heads or school NLC coordinators. 4. School heads shall likewise submit **printed and signed hard copies** of the list or registry of learners as well as the signed list of volunteers as prescribed in Div. Memo 267 s.2024 to their respective districts for consolidation. The deadline of the said documents at the division office shall be on or before **May 17, 2024**.

5. In reference to DM-OUCT-2024-097 and Joint DM of the OUCT-OUF-OUHROD dated April 15, 2024, public schools district supervisors shall accomplish the **District Consolidated Data of NLC Learners and LCV Requirement** (Grades 1, 2, 3, 7, 8, 9, and 10) as per Annex 4-D of the above issuance. Attached in this division memo is a copy of the said form which shall also be submitted on **May 17, 2024** along with the school registry of teachers and learners on NLC within the district.

6. Meals of participants and other expenses of the said activity shall be charged against school MOOE/local funds subject to usual accounting and auditing rules and regulations.
7. Other provisions in DM 267 s. 2024 shall remain in effect.
