- 1. As per <u>DepEd Order No. 008</u>, s.2019 dated May 2, 2019, School MOOE shall be used, among others, to fund minor repairs of facilities, buildings and grounds maintenance necessary for the upkeep of the school.

FUNDING FOR MINOR REPAIRS OF FACILITIES, BUILDINGS AND GROUNDS MAINTENANCE USING SCHOOL MOOE

- To: Assistant Schools Division Superintendent Chief Education Supervisor, SGOD/CID Public Schools District Supervisors Elementary and Secondary School All Others Concerned
- 1. As per <u>DepEd Order No. 008, s.2019</u> dated May 2, 2019, School MOOE shall be used, among others, to fund minor repairs of facilities, buildings and grounds maintenance necessary for the upkeep of the school.
- 2. Additionally, DepEd Order No. 1, s.2017 entitled Guidelines on the National Inventory of <u>DepEd Public School Buildings</u> for SY 2016-2017 defines minor repairs as:
 - a. **Rooms** -refers to the repair or replacement of room components which are not subjected to critical structural loads and stresses and which are estimated to cost less than ten percent (10%) of the cost of a standard room unit such as repair of windows, doors, partitions and the like:
 - b. **Buildings** refers to the repair or replacement of <u>school building</u> components which are not subjected to critical structural loads and stresses and which are estimated to cost Php 10,000.00 or less per classroom such as replacement of roof frames, posts, beams and exterior walls.
- 3. School Heads shall consider the above-mentioned policies in crafting their school plans.
- 4. Before executing repairs, the school shall secure an <u>Agency Estimate</u> or <u>Program of Works (POW)</u> first to determine if such repair adheres to the DepEd Orders mentioned. See Program of Works (POW) Template at <u>bit.ly/calbayogef</u>
- Payment of Labor Cost -30% of purchased materials.
- 6. Photos of Buildings, Classrooms, Grounds, etc. to be repair must be attached before the implementation.
