- 3. Learners are advised to take note of the following

a. Bring 3 carpules of Lidocaine HCL + Epinephrine (Dental Anesthesia) if no dental supply is available.

- b. Learners (patient) below 18 years old who will undergo treatment such as tooth extraction and fluoride application should bring their parents' consent permit.
- 4. Provide medicine to patient who will undergo Dental treatment and prescribe supplies if not available in school.
- 5. Schools may procure Dental Anesthesia and Medicine needed during tooth extraction and post dental procedure, charged to MOOE if it is included in the SIP/AIP and if not found in SIP/AIP must submit supplemental SIP/AIP to be able to procure Dental Supplies charged to MOOE subject to the usual accounting and auditing rules and procedure.
- 6. This memorandum shall also serve as Travel Order of the Dentist and Dental Aide
- 7. For immediate dissemination to all concerned.
