

- 1. In compliance to Republic Act No. 11036 or the Mental Health Act of 2018 which mandates DepEd to provide guidelines to schools in the development and implementation of mental health program, this Office through the Health and Nutrition Section will conduct an orientation for all elementary and secondary schools Guidance Counsellors/Guidance Designates/ Nurses on Rapid HOME, EDUCATION & EMLOYMENT, ACTIVITIES, DRUGS, SEX AND RELATIONSHIPS, SELF-HARM AND DEPRESSION, SAFETY AND ABUSE (HEADSSS) Assessment and Referral Mechanism for Guidance Counsellors/Guidance Designates / Nurses on October 18, 2024 (Batch 1) and October 25, 2024 (Batch 2) at the Division Conference Hall.
- 2. The said activity aims to promote mental health awareness, identify individual at risk and provide support, and facilitate access including referral mechanism of learners and employees requiring psycho-social support.
- 3. No registration fee shall be collected, Lunch and Snacks of participants shall be against Program Support Fund of School Mental Health Program, subject to usual accounting and auditing rules and regulations.
