- 5. Learners who are attending the JDVP training and assessment should be given time to obtain necessary requirements to avoid disruption of their academic performance.
- 6. A Service Credit shall be given to teachers who are involved during the JDVP monitoring on Saturday while school heads and division personnel shall be granted Compensatory Time Off (CTO). This is in compliance to Civil Service Commission (CSC), the Department of Budget and Management (DBM) and Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service rendered.
- 7. All other provisions stipulated in the previous Memorandum remain in effect.
- 8. This Memorandum shall serve as **Travel Authority** of all the participants.
- 9. Immediate dissemination of and compliance with this Memorandum are desired.
