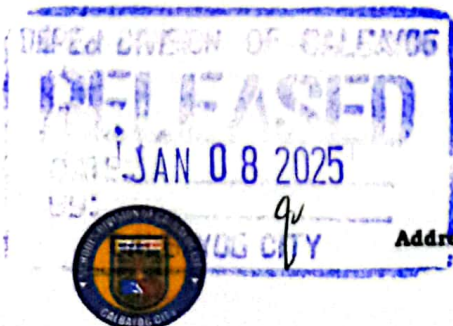



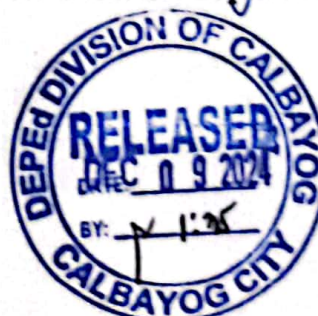

- determine the requirements and documents to be submitted through the CPDAS;



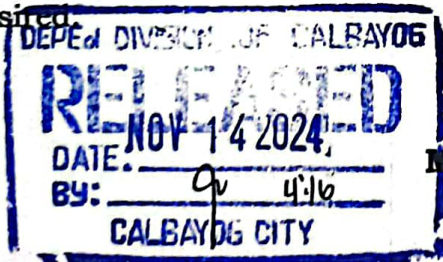

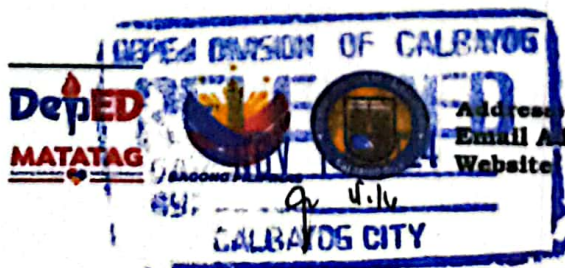

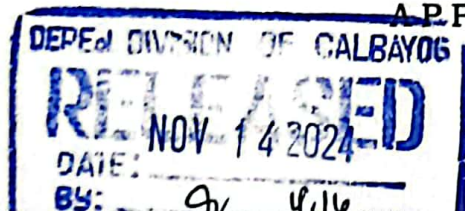
