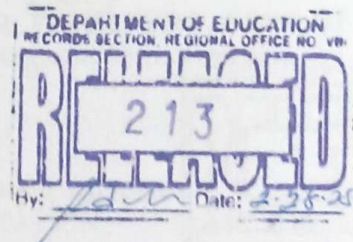



This Office, through the Curriculum and Learning Management Division (CLMD), in its continued implementation of Project *Padayon*, shall conduct a Orientation-cum-Planning on the Administration, Interpretation, and Utilization of the Independent Learning Readiness Test (ILRT) for the ADM, hosted by Tacloban City Division on November 26 - 29, 2024. 2. The activity aims to:

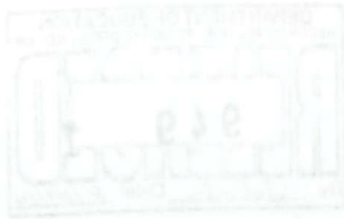
