- 1. In line with the Department's thrust towards strategic planning and evidence-based decision-making, and pursuant to DepEd Order No. 029, s. 2022 entitled "Monitoring and Evaluation Framework (BEMEF) for Data-Driven Decision Making", this Office, through the Office of the Schools Division Superintendent and the Planning and Research Section (PRS), announces the conduct of a Catchment Area Study Using Automated Mapping and School Form 1 Data.
- 2. In line with the conduct of this study, an innovation developed by the aforementioned proponents on School Form 1 Data Extraction and Automated Mapping shall be utilized to streamline the processing of learner location data, enhance data visualization, and ensure accuracy and efficiency in the identification of school catchment areas.
- 3. This study, together with the utilization of the innovation, aims to:
 - a. establish an accurate record of each school's official catchment barangays;
 - b. identify the proportion of learners residing outside their declared catchment areas;
 - c. analyze factors influencing out-of-catchment enrollment; and
 - d. generate data-driven recommendations to inform school planning, resource allocation, and stakeholder engagement and partnership.
- 4. The conduct of this study shall follow the process flow and schedule indicated below to ensure systematic implementation, accountability of responsible offices, and adherence to prescribed timelines:
