- 1. In reference to the letter request from the City Drug Abuse, Prevention and Rehabilitation Office (CDAPRO), the Schools Division of Calbayog City, through the SGOD-Learner Formation Unit and in collaboration with the said office, will conduct a forum entitled LECTURE/FILM SHOWING AND OPEN FORUM "AGAINST ILLEGAL DRUG ABUSE" WITH MENTAL HEALTH TALKS on August 22, 2025, at the Division Conference Hall.
- 2. This undertaking aims to achieve the following objectives, aligned with the Department of Education's commitment to promoting a drug-free environment, fostering holistic development, and addressing mental health concerns among learners, pursuant to DepEd Order No. 12, s. 2009 and DepEd Memorandum No. 200, s. 2016, entitled "Strengthening the National Drug Education Program in Schools" and as stipulated in various other DepEd Orders and Memoranda in drug education and prevention programs, and mental and psychosocial support services:
 - a. to enhance the knowledge and understanding of BKD Learner Officers and Teacher Advisers regarding the ill effects of illegal drugs on individuals, families, and communities;
 - b. to provide insights into the crucial link between mental health and drug abuse, emphasizing the importance of mental well-being in preventing substance use;
 - c. to equip participants with accurate information and practical strategies to effectively counter drug abuse and promote positive mental health within their respective schools and communities;

- d. to strengthen the advocacy and leadership roles of BKD Learner Officers in promoting and advocating for mental health awareness among their peers;
- e. to empower BKD Teacher Advisers in guiding and supporting their BKD organizations in implementing relevant anti-illegal drug activities and integrating mental health support; and
- f. to foster a strong partnership between the Schools Division of Calbayog City and the City Drugs Abuse Prevention and Rehabilitation Office (CDAPRO) in sustained fight against illegal drugs and in promoting mental health awareness.

Moreover, all teacher-advisers who will attend shall secure a **Displacement Form** to ensure that classes will be taken charge of by someone, in adherence to the provisions of DepEd Order No. 34, s. 2022. The school head shall sign the form and supervise the displacement of classes.
- 6. Furthermore, the conduct of the activity shall strictly adhere with the existing laws, policies, and regulations:
 - a) DepEd Order No. 40, s. 2012 Child Protection Policy
 - b) DepEd Order No. 9, s. 2005 "Instituting Measure to Increase Engaged Time-on-Task" or No Disruption-of-Classes Policy"
 - c) DepEd Order No. 19, s. 2008 "Implementation of No Collection Policy in all Public Elementary and Secondary School"
 - d) RA 10173 Data Privacy Act of 2012
- 7. The travel expenses and meal allowance of participants shall be charged against their school MOOE/local funds/other funds, subject to the usual accounting and auditing rules and regulations.
