- Attached are Memorandum DM-OUOPS-2025-10-02789 from the Office of the Undersecretary for Operations dated April 30, 2025 and Memorandum DM-OASOPS-2024-11-604 from the Office of the Assistant Secretary for Operations dated November 27, 2024 proving Guidelines on the Conduct of the Career Guidance Program School-Based Training of Career Advocates.
- 2. This Region successfully conducted the First Batch of the activity on June 30 to July 4, 2025. Pursuant to the provisions of the attached Guidelines, each identified school is required to send two (2) Career Guidance Advocates, consisting of one (1) male and one (1) female representative. However, it has been observed that several schools designated only one (1) participant, which constitutes a deviation from the prescribed requirements.
