**REGISTRATION OF QUALIFIED ALS LEARNERS FOR THE CONDUCT OF THE 2025 ACCREDITATION AND EQUIVALENCY (A&E) TEST**

1. Pursuant to the directives of the Bureau of Alternative Education (BAE) and during the virtual orientation held last September 24, 2025 in line with the conduct of the **2025 Accreditation and Equivalency (A&E) Test comes March 1, 2026**, this office through the School Management, Monitoring and Evaluation (SMM-E) of the School Governance and Operations Division in coordination of the Curriculum and Implementation Division announces the **registration of qualified ALS learners** for both elementary and junior high school levels from **September 29, 2025 to November 4, 2025**.

2. Qualified registrants include:

a. ALS learners aged at least 12 years old for the A&E Elementary Level and at **least** 16 years old for the A&E Junior High School Level on or before the examination day who are enrolled in the Learner Information System (LIS) for SY 2025-2026 or before October 31, 2025;

b. Previous ALS Program Completers who are not registered in the LIS of the current school year and have not taken either the Presentation Portfolio Assessments (PPA) or the Accreditation and Equivalency(A&E) Test; Eligibility of Test Registrants and Requirements; and

c. Previous ALS Program Completers who are not registered in the LIS of the current school year and have not passed either the Presentation Portfolio Assessment (PPA) or the Accreditation and Equivalency (A&E) Test BUT underwent additional learning intervention in the ALS K to 12 Basic Education Curriculum (BEC), certified by the ALS Teacher/Community ALS Implementer/Learning Facilitator;

3. The schedule and requirements of registration are as follows:

a. **Registration Period:** September 29 to November 4, 2025.

**Venue:** Division ALS Center/ Library hub.

b. **Requirements:**

- 3 recent 1x1 ID pictures (white background with nametag).

- Original and one (1) Photocopy of Birth Certificate (PSA). In case PSA Birth Certificate is not available, the original and one (1) photocopy of the following documents can be presented:
  - Baptismal Certificate;
  - Voter's ID;
  - Valid Passport;
  - Valid Driver's License; or
  - Any Legal Document bearing the applicant's picture, name, signature and date of birth (e.g. NBI Clearance, Police Clearance).
- Original and one (1) photocopy of ALS Form (AF) 5 prepared by the Division ALS Implementer/ EPSA.
- Original and one (1) photocopy of the PPA result evaluated by the EPSA or Certificate of Rating (COR). This applies to those program completers who did not pass the PPA or A&E Test.
