- 1. In compliance with DepEd Order No. 10, s. 2018, entitled Guidelines on the Issuance of Special Orders for the Approval of the Eligibility for Graduation from Senior High School of Grade 12 Learners Enrolled in Private Schools/Colleges and Technical-Vocational Institutions, and to ensure proper documentation and record-keeping in the Division Office, all private senior high schools under the jurisdiction of the Schools Division Office Calbayog City are hereby directed to submit scanned copies of approved Special Orders (SOs) for their senior high school graduates covering School Years 2020-2021 onwards.
- 2. The submission aims to centralize records for easy retrieval, monitoring of compliance with graduation eligibility requirements, and support for future audits or verifications by the Regional Office or Central Office.
- 3. Submission Guidelines:
  - a. **Format:** Scanned copies must be in PDF format, clearly legible, and include the full SO document with signatures and approvals.
  - b. **File Name:** Use the format [SY][SchoolID][Number of Graduates]\_[SO Number].pdf (e.g., SY2020-2021\_CalbayogPrivateHS\_50\_SO001.pdf).
  - c. **Platform:** Submissions shall be uploaded via this link: <a href="https://bit.ly/CalbPrivateScoolsSpecialOrders">https://bit.ly/CalbPrivateScoolsSpecialOrders</a>.
  - d. Deadline: All submissions must be completed on or before November 15, 2025. However, for the incoming SYs, it is expected that the concerned schools must submit the said document five (5) days after

its receipt. Late submissions may incur delays in processing future requests.

- 4. School Heads are advised to designate a focal person to oversee the compilation and submission of these documents. A confirmation receipt thru the Official Chat Group with Private Schools will be issued upon successful upload.
