CONDUCT OF INITIAL VAIDATION OF PRESENTATION PORTFOLIO ASSESSMENT (PPA) of ALS LEARNERS FOR 2025 ACCREDITATION AND EQUIVALENCY (A&E) TEST

- 1. Pursuant to Advisory No. 027, s. 2025 titled "Orientation for the 2025 Accreditation and Equivalency (A&E) Test Registration and Administration" issued by the Department of Education through the Bureau of Education Assessment (BEA) dated September 12, 2025, it is clearly stated that the Presentation Portfolio Assessment (PPA) serves as a prerequisite for all ALS Learners to quality for the 2025 A&E Test.
- In compliance with the said advisory and in alignment with the provisions of **DepEd Memorandum No. 022 s. 2023** title "Guidelines on the Conduct of Presentation Portfolio Assessment for Alternative Learning System Accreditation and Equivalency Elementary and Junior High School Leaners", the Schools Division of Calbayog City, through its Alternative Learning System (ALS) Section, shall conduct the **Initial Validation of PPA** of ALS Learners who are prospective registrants for the 2025 A&E Test.


3. The Initial Validation aims to:

- a. Ensure that all submitted learner portfolios are complete, authentic, and compliant with the required components;
- b. Confirm that learners have achieved the expected learning outcomes in the identified learning strands; and



- c. Provide technical feedback and assistance to ALS teachers for the improvement of portfolio quality prior to the Final Validation and Endorsement for the 2025 A&E Test.
- 4. The Initial Validation of PPAs shall be conducted from October 21–29, 2025, at the respective ALS Learning Centers, , with assigned Division Validators composed of the Division ALS Focal Person, Education Program Specialists in ALS, and selected ALS Teachers.
- 5. All **ALS Teachers** are directed to submit the PPAs of their learners within the prescribed period following the standard format and documentation requirement stipulated in DM No. 002, s. 2023/
- 6. A Checklist of Validation Requirements and Criteria (Enclosure No. 2(is attached for uniform reference during the conduct of validation. The Schedule of Validation is also provided as Enclosure No. 1.
- 7. This Memorandum shall serve as **Travel Order** for the personnel involved in the conduct of the said activity.
- 8. All concerned are enjoined to give their full support and cooperation in ensuring the smooth conduct of the activity, as the results of the validation will serve as the basis for the endorsement of TEST REGSITRANTS to 2025 A&E Test.
- 8. Immediate and wide dissemination of this Memorandum is directed.
