**ASSIGNMENT OF TEACHER-NURSES AS AUGMENTATION TO THE DIVISION
HEALTH PERSONNEL DURING THE CONDUCT OF THE 2025 CITY-WIDE MEET**

3. The following Teacher-Nurses are hereby assigned as augmentation support to the Medical Team:

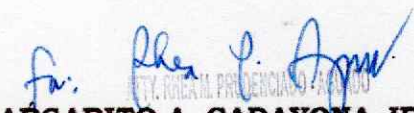

5. They are entitled to service credits/compensatory time-off (CTO) equivalent to the number of days rendered, in accordance with Civil Service Commission (CSC) and DepEd guidelines.
6. School Heads are directed to ensure minimal disruption in classroom instruction through effective and efficient Catch Up Plan.
7. Transportation, meals, and other incidental expenses shall be charged against Division MOOE/School MOOE/SEF, subject to usual accounting and auditing rules.
8. All concerned are enjoined to extend full support and cooperation for the smooth and safe conduct of the 2025 CCAAM.
