

**FREE THEORETICAL DRIVING COURSE (TDC) FOR TEACHING AND NON-TEACHING PERSONNEL**

1. The Schools Division of Calbayog City, in partnership with the **Land Transportation Office (LTO) – Calbayog District Office**, announces the conduct of a **Free Theoretical Driving Course (TDC)** for interested teaching and non-teaching personnel of the Division.
2. The TDC is a **mandatory requirement** for obtaining a Student Driver's Permit under existing LTO rules and regulations. This initiative aims to promote:
  - Road safety awareness
  - Responsible and defensive driving behavior
  - Compliance with traffic laws
  - Safer school and community environments
3. The activity will be held on **three (3) consecutive Saturdays: February 7, 14, and 21, 2026** (Venue and specific schedule will be announced once finalized).
4. The Theoretical Driving Course will cover the following topics:
  - Basic traffic rules and regulations
  - Road signs and pavement markings
  - Defensive driving principles
  - Driver's responsibilities and traffic violations
5. Participants who complete the course will receive an **LTO-issued TDC Certificate**, which may be used as a supporting document for securing a Student Permit at any LTO office.

Respectfully, this is to propose the conduct of a Free Theoretical Driving Course (TDC) for all teaching and non-teaching personnel under the Schools Division of Calbayog City to be facilitated by the Land Transportation Office Calbayog District Office.
