1. In reference to DepEd Memorandum No. 098, s. 2025, this Office announces the conduct of the 2026 Regular Philippine Educational Placement Test (PEPT) on **February 22, 2026, 6:30 AM** at **Calbayog City National High School (CCNHS)**.
2. Pursuant to the said Memorandum, the PEPT is administered to learners in special circumstances (overage, school-less, or those in informal education) to provide them the opportunity to resume formal schooling or obtain certification of their grade level competencies.
3. All examinees are required to bring the following on examination day:
 - One (1) piece **1x1 ID picture** (white background) with name tag;
 - Two (2) Mongol No. 2 pencils; and
 - Packed food and drinking water.
4. The designated Division Testing Personnel are directed to report to the testing venue at least one (1) hour before the examination schedule to ensure proper room preparation, orientation, and strict observance of testing protocols, including confidentiality and security of test materials.


