5. Only individuals meeting the following conditions shall be eligible to participate:
  - a. Physically fit and submit the latest Medical Certificate.
  - b. For Officiating Officials not more than 50 years old.
6. The 39 participants from 13 Divisions are required to bring their own sleeping kits, toiletries, and other paraphernalia necessary for the duration of the activity.
7. Consistent with the rulings under DepEd Order No. 67, s. 1988 and CSC Memorandum Circular No. 9, s. 1988, those who travel or render services on days that fall on holidays, weekends, and summer breaks shall be entitled to avail of service credits or CTO equivalent to eight (8) hours of service per day, whichever is available.
8. Food, travel, and incidental expenses—including board and lodging for the participants—shall be charged against their respective Local Funds/MOOE/SEF/Palarong Pambansa funds and other available sources, subject to the usual accounting and auditing rules and regulations.
9. Immediate dissemination of and compliance with this Memorandum are desired.
