1. This Office announces the schedule for the **Oath Taking Ceremony, Orientation, and General Plan of Action (GPOA) Crafting of the Division Federation Officers of the Supreme Secondary Learners Government (SSLG), Supreme Elementary Learners Government (SELG), Barkada Kontra Droga (BKD) and Youth for Environment in Schools Organization (YES-O)** which will be conducted on **July 11, 2026, (Saturday)** at the Calbayog City Division Conference hall, starting exactly at 8:00 AM.
2. The objectives of this activity are as follows:
  - To officially induct the newly elected Division Officers of SELG, SSLG, BKD, and YES-O for School Year 2026-2027 through a formal Oath-Taking Ceremony, instilling a deep sense of responsibility and accountability;
  - To orient the student leaders on their specific roles, functions, and constitutional guidelines to ensure effective governance within their respective organizations;

4. The teacher-advisers and non-teaching personnel shall serve as the chaperones of the learner-participants during the activity. Identified division and school personnel shall be granted **one (1) day of Service Credit** (for teaching personnel) or **Compensatory Time-Off (CTO)** (for non-teaching personnel) for services rendered on a Saturday, in accordance with DepEd Order No. 53, s. 2003. Furthermore, school heads and advisers must secure that duly signed Parental Consent Forms for all learner-participants are secured prior to the travel.

Meals of the participants and all other operational expenses incurred in the conduct of this activity shall be charged against the **Learner Support Program (LSP) Fund for the Implementation of Youth Formation Programs**. Travelling expenses of the participants shall be charged against their respective School MOOE, local, or other available funds, subject to the usual accounting and auditing rules and regulations.
