1. In preparation for the hosting of the Eastern Visayas Regional Athletic Association (EVRAA) Meet 2027, a **Special Meeting with the EVRAA 2027 Secretariat** is hereby called on **July 10, 2026, at exactly 3:00 PM.**
2. The venue for this meeting will be at the **CMO-LTPDC Office, L2 Handumanan Building, Calbayog City.**
3. The agenda of the meeting shall include the following:
 - a. Initial planning and task mapping for the upcoming EVRAA 2027 hosting;
 - b. Presentation and finalization of committee compositions;
 - c. Timelines for preparatory activities and local sports coordination; and
 - d. Other operational matters.
4. To ensure that the delivery of basic education services remains uncompromised, the **"No Disruption of Classes"** policy must be strictly observed pursuant to **DepEd Order (DO) No. 009, s. 2026** (Guidelines on the Implementation of the Three-Term School Calendar in Basic Education).
5. School heads of identified secretariat members are directed to prepare subject displacement plan and/or implement necessary administrative mechanisms—such as the adoption of alternative instructional delivery modes or assigning internal substitute teachers—to guarantee that the learners' instructional time is fully protected.

7. Attendance of all identified secretariat members is highly expected. Travel expenses incurred by the participants shall be charged against local funds/MOOE, subject to the usual accounting and auditing rules and regulations.
