RELOCATION OF CALBAYOG CHRISTIAN FAITH ACADEMY, INC.**

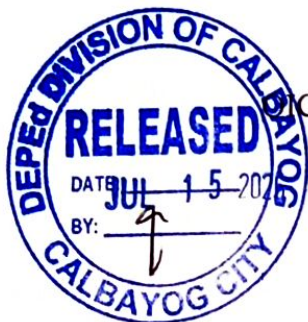

1. Pursuant to Regional Memorandum QAD-2026-843 dated July 6, 2026, this Office, through the School Governance and Operations Division (SGOD), hereby announces the approval of the request for temporary relocation of Calbayog Christian Faith Academy, Inc., Division of Calbayog City, Samar.
2. Calbayog Christian Faith Academy, Inc. (CCFAI) is authorized to temporarily operate at its proposed relocation site located at DELA CRUZ/PEARSON Building, Magsaysay Boulevard Extension, Barangay Rawis, Calbayog City, Samar, beginning School Year 2026-2027 until further notice or until its original facilities are declared structurally sound and certified safe for occupancy.
3. The school's temporary operations are strictly subject to the following conditions outlined in the Regional Memorandum:
 - a. Continuous compliance with all applicable provisions of DepEd Order No. 88, s. 2010 (2010 Revised Manual of Regulations for Private Schools in Basic Education);
 - b. Maintenance of adequate facilities, instructional resources, and a conducive learning environment at the temporary site;
 - c. Compliance with health, safety, sanitation, and occupancy standards prescribed by concerned government agencies;
 - d. Submission of periodic reports on the status of the rehabilitation, repair, or remediation of the school's original facilities; and
 - e. Allowing monitoring and validation visits by authorized DepEd personnel whenever necessary.

4. The SGOD, through the Private Schools Coordinator, SEPS-SMM&E, and the Division Engineer, shall conduct periodic monitoring visits to ensure continuous adherence to the standard safety and operational protocols.
5. Immediate dissemination of and strict compliance with this Memorandum are desired.

**APPROVAL OF THE REQUEST FOR TEMPORARY RELOCATION OF
CALBAYOG CHRISTIAN FAITH ACADEMY, INC.,
DIVISION OF CALBAYOG CITY, SAMAR**

1. Pursuant to the request of **Calbayog Christian Faith Academy, Inc.**, Division of Calbayog City, Samar, for the temporary relocation of its operations, and upon evaluation of the supporting documents by the Quality Assurance Division, which found the school compliant with the applicable requirements under DepEd Order No. 88, s. 2010, otherwise known as the *2010 Revised Manual of Regulations for Private Schools in Basic Education*, this Office hereby approves the temporary relocation of the school to its proposed site.

2. The approval is further anchored on the report and recommendation of the Division Engineer, which disclosed structural deficiencies in the school's existing facilities that may adversely affect the safety, security, and welfare of learners, teaching and non-teaching personnel, and other stakeholders. Considering the need to ensure a safe and conducive learning environment and to prevent disruption of educational services, the temporary relocation of the school is deemed necessary and justified.

3. In view thereof, **Calbayog Christian Faith Academy, Inc.** is hereby authorized to temporarily operate at its proposed relocation site located at **DELA CRUZ/PEARSON Building, Magsaysay Boulevard Extension, Barangay Rawis, Calbayog City, Samar, beginning School Year 2026-2027** until further notice or until its original facilities have been restored, declared structurally sound, and certified safe for occupancy by the appropriate authorities.

4. The approval is subject to the following conditions:
- Continuous compliance with all applicable provisions of DepEd Order No. 88, s. 2010, and other relevant DepEd issuances governing private schools;
 - Maintenance of adequate facilities, instructional resources, and learning environment at the temporary site;
 - Compliance with health, safety, sanitation, and occupancy standards prescribed by the concerned government agencies;
 - Submission of periodic reports on the status of the rehabilitation, repair, or remediation of the school's original facilities; and

- e. Allowing monitoring and validation visits by authorized DepEd personnel whenever necessary.
5. This approval is granted in the interest of safeguarding the welfare of learners and personnel while ensuring the uninterrupted delivery of quality basic education services.
6. Immediate dissemination of and compliance with this Memorandum are desired.
