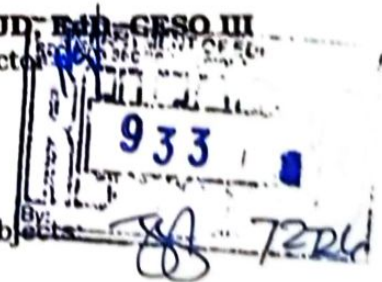

The National Federation of Supreme Secondary Learner Government (NFSSLG) is the highest federation of the Learner Government, serving as the foremost representative and voice of learners at the national level. Section 7. Proclamation of Winners

Upon the completion of the canvassing and determination of the winner for each elective position, the Presiding Officer shall immediately proclaim the duly elected officer before the election for the succeeding position commences.

After all elective positions have been filled, the Presiding Officer shall officially recognize all remaining RFSSLG Presidents who were not elected to any national elective position as Board Members.

The decision of the National Election Committee regarding the canvassing, determination of winners, and proclamation shall be final unless a formal election protest is filed. Any election protest must be filed within ten (10) days from the date of proclamation of the elected officer concerned; otherwise, the proclamation shall be deemed final and executory.

Section 8. Oath of Office

Immediately following the proclamation, the newly elected National Officers and National Board Members shall take their Oath of Office before the designated administering officer.

Section 9. Adjournment

Upon completion of the Oath-Taking Ceremony, the Presiding Officer shall formally declare the election proceedings adjourned.
