1. In accordance with **Republic Act No. 11913**, otherwise known as the Act Declaring August 12 as National Youth Day Act, and **Republic Act No. 8044**, otherwise known as the Youth in Nation-Building Act, the City Government of Calbayog, through the City Youth Development Office (CYDO), will celebrate National Youth Day 2026 on **August 15-16, 2026** at the **Calbayog City Convention Center, Brgy. 5. The Teacher-Advisers/Coordinators or Non-Teaching Personnel who will render services on Saturday and Sunday, August 15-16, 2026, shall be granted service credit for the services rendered, subject to existing DepEd rules, regulations, and applicable guidelines on the grant of service credits.
6. For the safety and welfare of the student participants, **every student participant shall secure a duly accomplished Parental/Guardian Consent Form** prior to participation in the activity. The concerned school shall ensure that the consent forms are properly accomplished, collected, and kept on file.
7. The School Heads are requested to ensure that the participating students and their accompanying teachers are properly oriented on the program, schedule, responsibilities, and other necessary arrangements relative to the activity.
8. The attached Program of Activities from the City Youth Development Office is hereby provided for the information and appropriate guidance of all concerned.
9. Immediate dissemination of and compliance with this Memorandum are hereby enjoined.
